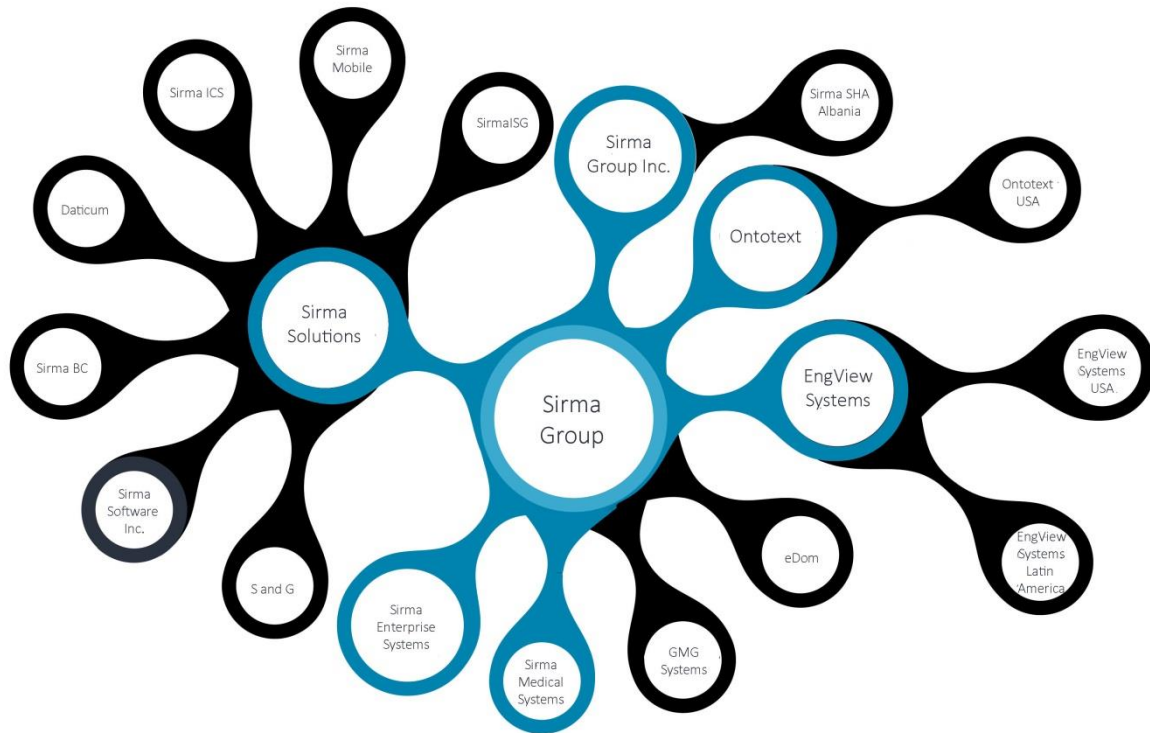

#### SUBSIDIARIES:

„Sirma Solutions“ JSC is a subsidiary of SIRMA GROUP HOLDING JSC and the control is acquired and exercised through the direct participation of the parent company in the ownership of Sirma Solutions.

**Capital Amount: BGN 32 319 700.**

„EngView Systems Sofia“ JSC is a subsidiary of SIRMA GROUP HOLDING JSC, the control being acquired and exercised through the direct participation of the parent company in the ownership of EngView Systems Sofia.

**Capital Amount: BGN 68 587**

„Sirma Enterprise Systems“ JSC (SES) is a subsidiary of SIRMA GROUP HOLDING JSC and the control was acquired and exercised through the direct participation of the parent company in the ownership of Sirma ITT PLC as of 30.06.2014. , as follows - until 1.06.2014 subsidiary of Sirma Solutions , from 01.06. 2014 to 30.06.2014 the group loses control over the company as it was acquired by an American person, on 30.06.2014 SCG acquires 100% of the company.on 15.07.2016 "Sirma ITT" changed its name to "Sirma Enterprise Systems".

Sirma Group Inc. is based in New York and headed by the Board of Directors, consisting of: Tsvetan Alexsiev, Yavor Djonev and Atanas Kiryakov. Responsible for the company's operations are Tsvetan Alexsiev - Chairman of the Board of Directors and responsible for financial operations and Yavor Djonev - Executive Director of the company, one of the co-founders and visionaries of Sirma since its inception in 1992 and has a rich international experience . The Holding Board's decision provides for the first-stage development company to concentrate on expanding sales volumes on the US and nearby markets of the group companies by building a strong team of traders with whom the group can set up confidently on the East Coast USA.

Pursuant to the Strategy of Sirma Group Holding JSC, on 04.05.2018 two of the subsidiaries of the Holding were merged: Sirma Group Inc. and Sirma USA.

The new company from 08.05.2018 will be Sirma Group Inc. and will be based in the USA, Idaho 83702, Boise 202 N, 9th Street Suite 303B.

**Sirma Software Inc** - On March 13, 2018, a new subsidiary of Sirma USA Inc., a part of Sirma Group Holding JSC - Sirma Software Inc., was set up as follows:

The Company was created for the purpose of separating Sirma Group Holding's assets from Sirma USA in the newly established company, according to the Group's Strategy.

On March 14, 2018, with a share transfer agreement concluded between Sirma USA Inc. on the one hand and Sirma Solutions JSC and Sirma Group Inc. on the other, all 11,711,476 ordinary shares with a nominal price of USD 1.00 from the capital of Sirma Software Inc. was transferred to Sirma Solutions JSC and Sirma Group Inc. in 97.5% of the capital (11,418,689 shares) of Sirma Solutions JSC and 2.5% of the capital (292,787 shares) of " Sirma Group Inc. ".

The deal is part of a series of actions to separate Sirma Group Holding's core assets from Sirma USA at Sirma Software Inc., in line with the Group's Strategy.

#### ASSOCIATED COMPANIES:

**GMG Systems Inc.** (in process of liquidation) is a joint venture of Sirma Group Holding, founded in 2003. The company specializes in the design, manufacture and installation of a full range of parking equipment. The product range includes on-site parking systems, ticket vending machines, automotive barriers, video surveillance and recording systems, street parking parks, and more.

Some of the functionalities of the products are: video processing, real-time audio playback, web based user interface and remote control, integration of different kinds of parking facilities, card access systems, etc.
