

# Business development in 2023

### Sirma Solutions

On March 30, 2023, the sale of "Sirma AI" AD was finalized. Following the decision of the General Meeting of Shareholders from Feb 5.,2023, "Sirma Solutions" JSC sold its 1,603,759 ordinary shares and 308,508 class A shares from the capital of "Sirma AI"JSC for the total amount of EUR 9,460,000;

Sales of the largest company in the holding increased by 15% during the year. At the same time, the system for paying fees to "Sirma Group Holding" JSC was changed, and they are now related to the turnover of the company. Hence, "Sirma Solutions" JSC realizes a loss in 2023. We are convinced that in 2024, the company will acclimatize to the new internal regulations. In 2023, Sirma Solutions JSC greatly shortened the supply chain when providing hardware equipment for its customers. This approach paid off almost immediately, lowering the cost to the end user and thus greatly increasing sales volume. While sales of services in 2023 grew slightly compared to 2022, hardware sales saw growth of almost 21% over the same period last year.

### Daticum

The company's service revenues in 2023 will exceed those in 2022 by nearly 15%. The profit for 2023 exceeds that of 2022 by nearly 10%. New significant clients are one of the largest freight forwarders in Romania, one of the largest grocery chains in North-Eastern Bulgaria – Bulmag, the startup Data Lab;

### Sirma Business Consulting


SBC's sales increased by nearly 29% in 2023 compared to 2022. This resulted in the company returning to profitability during the year. SirmaBC has finalized several maintenance contracts and several new initiatives to renew electronic payment channels. A large part of the orders in 2023 were related to all the planned changes within the payment standards and the national plan for the transition to the euro.

### Sciant

Sciant JSC continued its sales growth, achieving 12% growth in 2023 compared to 2022. The profit achieved during the year is nearly BGN 800 thousand. New customers were attracted in Western Europe and North America from the existing verticals: Hospitality, Logistics and Transport, with a significant increase in business being noticed in Hospitality.

# Highlights in 2023

**February:** Following the decision of the General Assembly from 09.01.2023, "Sirma Group Holding" JSC proceeded to pay a cash dividend in the amount of gross BGN 0.015 per share for the first six months of 2022, or BGN 889,135.08;

April: On April 04, 2023, the remaining 22.2% of the capital of the subsidiary "Scient" JSC was bought by "Sirma Group Holding", which became its sole owner;

On April 12, 2023, "Sirma Group Holding" AD made a full early repayment of three of its investment bank loans, repaying the principal amounts of EUR 4,356,154;

On April 26, 2023 "Sirma Group Holding" JSC received registration of its new subsidiary in


Stockholm, Sweden. The name of the new company is "Sirma AB". "Sirma AB" will be commercially focused on the markets in the Scandinavian countries, BENELUX and German-speaking Europe;

June: Following a decision of the General Assembly "Sirma Group Holding" JSC proceeded to pay a cash dividend in the amount of gross BGN 0.0339 per share for the year 2022, or BGN 1,960,317.90;

H2: "Sirma Group Holding" JSC started preparations for the consolidation of its companies operating in the field of IT services.



# **Consolidation of Sirma**






# Possible synergies and a unified development path

- Sometimes the focus on serving a given vertical gets diluted



- full care and support of Sirma employees and striving to achieve their well-being


- We published our first "Non-financial declaration" voluntarily for 2022
